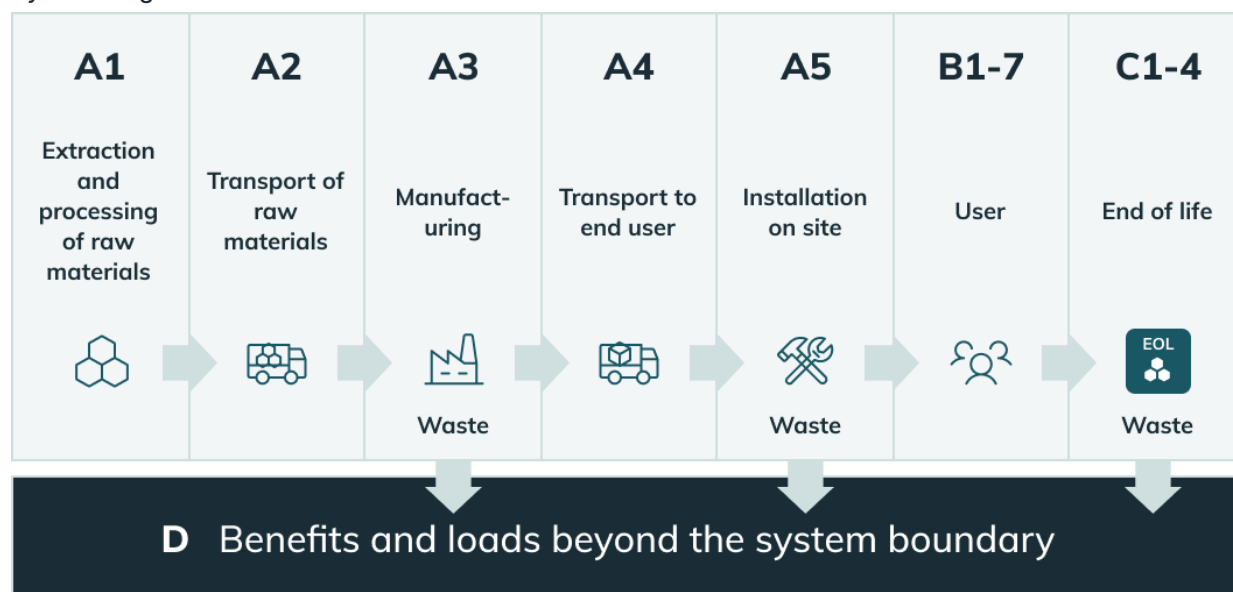

In the context of Norwegian public procurement legislation, GWP GHG is also referred to as GWP IOBC.

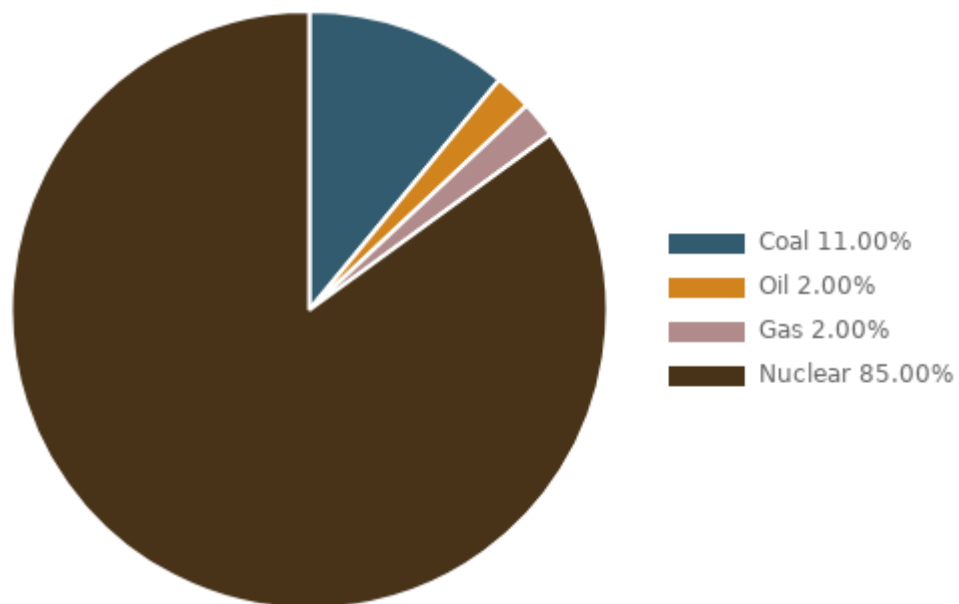
