


<u>Excluded lifecycle stages:</u> Transportation to retail, use stage and end-of-life stages are excluded.

<u>Cut-off rule:</u> 1% cut-off rule was applied for input flows in the inventory. Cut-off allocation of waste burdens and benefits in accordance with the polluter pays principle as stipulated in the PCR.

<u>Allocation:</u> Steel scrap produced in module A3 is treated as co-product and environmental impacts are allocated for it based on physical properties, and therefore, mass-based co-product allocation is applied.

Additionally, all used stainless steel comply with the restrictions in Annex XVII of the REACH Regulation.
