Declaration of Environmental Conformity

Dear Sir or Madam,

Pollmann Elektrotechnik GmbH manufactures products for electrical installation e.g. busbars, terminals and all accessories for panel builders and domestic installation.

We are committed to minimising the impact of our activities on the environment and, to that end, the use of cadmium, asbestos, halogen, PCB and mercury have been prohibited within the company for many years. We specify the use of additives at levels strictly below the limits set by legal requirements and no banned solvents or detergents are used in any manufacturing process. These rules are also a main constraint for all newly designed products. Pollmann Elektrotechnik GmbH specifies raw materials, semi-finished products, other purchased parts as well as established methods based on the following European directives:

- 2011/65/EU with update 2015/863/EU "RoHS III" and ban of deca-BDE
- 2006/1907/EU "REACH" including all SVHC*
- 2019/1021/EU "POP"
- 1005/2009/EU "Ozone Directive"

* SVHC (substances of very high concern). Our brass components containing more than 0.1 % lead as part of the alloy are registered with the ECHA (European Chemical Agency).

We also declare full compliance with the Toxic Substances Control Act (TSCA) issued by the United States Environmental Protection Agency (EPA), California Proposition 65 and the Montreal Protocol on Substances that Deplete the Ozone Layer.

As a result, our products are environmentally friendly and not critical for recycling processes fully accordant to the "Waste Directive" 2008/98/EU.

Furthermore, we do not use any of the conflict minerals, which have been banned by the Dodd-Frank Act, Section 1502. This is being monitored by using the latest release of the "Conflict Minerals Reporting Template" issued by the CFSI. This declaration is available on demand.
